

# Calmer Camping Hire Rental Agreement

Please read the following carefully as signing this rental agreement signifies that you agree to the stated terms and conditions:

- 1 Calmer Camping Hire's (CCH) weekly charge is \$1,100 per week (including GST/insurance). A security bond of \$2,000.00 is payable prior to departure (cash or direct deposit - preferred).
- 2 CCH minimum rental period is MINIMUM 7 days and daily thereafter (unless otherwise agreed).
- 3 A booking fee of \$275 or 25% of total hire cost (higher amount) must be paid before any Rental Agreement will be confirmed.
- 4 Full payment of the rental must be made 30 days prior to the "hire start date".
- 5 Cancellation fees: Full refund if more than 90 days' notice given. Half booking fee refunded with 90-28 days' notice. Booking fee forfeited if less than 28 days' notice given.
- 6 The minimum age of any CCH hirer must be 25 years. The minimum age of any person driving any vehicle towing any CCH T-Van must be 25 years and that person must hold and produce a copy of a valid Australian driver's license prior to departure.
- 7 All T-Van's are insured by CCH, In the event of a claim being made, Hirer's bond will be retained to pay excess of \$2000.00  
**PLEASE NOTE:** Insurance does not cover recklessness or malicious damage.
- 8 Only people nominated on the CCH Hire rental agreement are permitted to tow any CCH T-Van.
- 9 It is the hirer's responsibility to check and sign the "condition report" prior to hire. The hirer has 24 hours to report any damage to the T-Van that wasn't noted on pickup. After this time the hirer is responsible for any/all damage.
- 10 The T-Van must be returned to Unit 2/7 Keates Road Armadale WA 6112 on or before the "return date" of the Rental Agreement.
- 11 The T-Van must be returned in a clean condition or a minimum cleaning levy \$250 (depending on the condition of the van on return) will be charged accordingly.
- 12 Recovery of the T-Van from any other place than CCH, 2/7 Keates Road, Armadale WA 6112 will result in a minimum charge of \$275.00 (depending on its location) per day (or part thereof) for extra hire plus any costs incurred (including labour/transport/accommodation).
- 13 The cost of repair of any damage is the responsibility of the hirer and must be reported to CCH, 2/7 Keates Road, Armadale WA 6112, 08 9399 7794, info@calmercampinghire.com.au before any repair can be authorized and undertaken. Failure to do so will result in alternate and/or further work being undertaken at the hirer's expense. Alternatively, repairs may be better organized after return. ALL items from/in/on van to be returned, including damaged items which have been replaced.
- 14 **Any** tyre repair or **replacement** is the responsibility of the hirer and any replacement must be the same or equivalent tyre, size, quality, load rating etc. Failure to do so may result in a charge for the correct tyre to be fitted.
- 15 There are to be **NO** modifications made to the T-Van, rectification to standard will be at the hirers expense.
- 16 Any burn holes from ash/embers etc to the annex will result in a replacement of the annex at the hirer's expense.
- 17 Generally the extension of any Hire rental period would only be considered before the "return date" of the Hire rental agreement and may not always be possible. It is in the hirer's interest to give CCH as much notice of the request as possible.
- 18 Any late returns will be charged at a minimum of \$275.00 per day.
- 19 It is a condition of hire that all CCH T-Van's that there will be **no smoking** in the van or the attached annex. Failure to observe this will result in a cleaning and airing fee.
- 20 The following are no go areas: Any beaches or island where exposure to salt water may be likely, any salt water environment where salt water will come in direct contact with any part of the T-Van, any areas where the T-Van will be immersed in salt water, fresh water or muddy area where the emersion level will approach wheel bearing caps, overgrown, closed in or narrow tracks which may cause abrasion of the side panels. Disregard of these exclusions will very likely result in damages that the hirer will be liable for. Any variation to no-go areas must be agreed by CCH in writing/email BEFORE departure.
- 21 Any amount due to the hire provider (CCH) by way of insurance excess, cost of repairs, cleaning levy, recovery charge, tyre damage and or late return will be sought firstly from the security bond and the balance returned to the hire user within **14 days**
- 22 All T-Vans are equipped with a GPS tracking system for theft protection, customer safety and rental agreement validation (confirming it hasn't been on a beach). The hirer consents to the tracking information being stored by CCH. The GPS unit must not be disconnected or tampered with in anyway; non-compliance will result in full bond being forfeited.
